YourList Terms of Use

1. **ACCEPTANCE OF TERMS** YourList.org. ("YourList" or "yourlist") welcomes you. Yourlist.org provides its service to you subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. You can review the most current version of the TOS at any time at on our website at <http://www.yourlist.org>. This version was updated on December 15, 2010.
2. **DESCRIPTION OF SERVICE** YourList provides users with access to public issue reporting, discussing and management which may be accessed through various media or devices (the "Service"). You also understand and agree that the Service may include advertisements and that these advertisements are necessary for YourList to provide the Service. You also understand and agree that the Service may include certain communications from YourList, such as service announcements, administrative messages and the YourList Newsletter, and that these communications are considered part of YourList membership and you will not be able to opt out of receiving them. Unless explicitly stated otherwise, any new features that augment or enhance the current Service shall be subject to the TOS. You understand and agree that the Service is provided "AS-IS" and that YourList assumes no responsibility for the timeliness, deletion, mis-delivery or failure to store any user communications or personalization settings. You are responsible for obtaining access to the Service, and that access may involve third-party fees (such as Internet service provider or airtime charges). You are responsible for those fees, including those fees associated with the display or delivery of advertisements. In addition, you must provide and are responsible for all equipment necessary to access the Service.
3. **YOUR REGISTRATION OBLIGATIONS** In consideration of your use of the Service, you represent that you are of legal age to form a binding contract and are not a person barred from receiving services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the Service's registration or other forms (the "Registration Data") and (b) maintain and promptly update the Registration Data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or YourList has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, YourList has the right to suspend or terminate your account and refuse any and all current or future use of the Service (or any portion thereof). YourList is concerned about the safety and privacy of all its users, particularly children. For this reason, parents of children under the age of 13 who wish to allow their children access to the Service must take responsibility to determine whether any of the Service areas and/or Content (as defined in Section 6 below) are appropriate for your child.
4. **YOURLIST PRIVACY POLICY** Registration Data and certain other information about you is subject to our Privacy Policy. We will not share or sell your email with another company without your permission. You understand that through your use of the Service

you consent to the collection and use (as set forth in this Privacy Policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing and use by YourList.

5. **MEMBER ACCOUNT, PASSWORD AND SECURITY** You may receive a password and account designation upon completing the Service's registration process. You are responsible for maintaining the confidentiality of the password and account and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify YourList of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. YourList cannot and will not be liable for any loss or damage arising from your failure to comply with this Section 5.

6. **USER CONDUCT** You understand that all information, data, text, software, photographs, graphics, messages, tags, or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated. This means that you, and not YourList, are entirely responsible for all Content that you upload, post, email, transmit or otherwise make available via the Service. YourList does not control the Content posted via the Service and, as such, does not guarantee the accuracy, integrity or quality of such Content. You understand that by using the Service, you may be exposed to Content that is offensive, indecent or objectionable. Under no circumstances will YourList be liable in any way for any Content, including, but not limited to, any errors or omissions in any Content, or any loss or damage of any kind incurred as a result of the use of any Content posted, emailed, transmitted or otherwise made available via the Service.
You agree to not use the Service to:

 9. interfere with or disrupt the Service or servers or networks connected to the Service, or disobey any requirements, procedures, policies or regulations of networks connected to the Service;
 10. intentionally or unintentionally violate any applicable local, state, national or international law, and any regulations having the force of law;
 11. "stalk" or otherwise harass another; and/or
 12. collect or store personal data about other users in connection with the prohibited conduct and activities set forth in paragraphs a through m above.
7. You acknowledge that YourList may or may not pre-screen Content, but that YourList and its designees shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, or remove any Content that is available via the Service. Without limiting the foregoing, YourList and its designees shall have the right to remove any Content that violates the TOS or is otherwise objectionable. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy, completeness, or usefulness of such Content. In this regard, you acknowledge that you may not rely on any Content created by YourList or submitted to YourList, including without limitation information in YourList Issues and in all other parts of the Service.

 1. Statute of Limitations. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the Service or the TOS must be filed within one (1) year after such claim or cause of action arose or be forever barred.
